***Doug Page - Director of Policy and Legislation, Housing Policy Branch, BC Ministry of Municipal Affairs and Housing.*** BC's strata legislation and market housing affordability are currently two of his major responsibilities, but he has also been involved in the creation of both the Homeowner Protection Office and the Civil Resolution Tribunal.
